### Boulevard Saint-Joseph

Work has been undertaken on Saint-Joseph Boulevard to revitalize this artery. Work to rebuild infrastructure and surface development will be 2.74 km long between Saint-Raymond and Alexandre-Taché boulevards and some adjacent streets. The work program for Saint-Joseph Boulevard is being carried out in sections and 4 projects are planned for District 5, according to a schedule that will be adjusted as needed. We are aware of the problems generated by this work, but the redevelopment of Saint-Joseph Boulevard is a lever for revitalizing and enhancing this important commercial and traffic artery.

### Snow removal

Last year, winter was hard, and we had some failures when it came to snow removal. We are preparing to face this winter with new measures that we hope will make life easier for all. We have set up a full-time blower service without interruption, even when a storm strike. In addition, new machinery was added. We hope to respond to your concerns and expectations.

### Special waste collection

Special collections for construction and bulky materials were held on October 11 and 18, 2019. I invite you to visit the Ville de Gatineau and refer to the bulky waste and construction waste tabs for information on collection services: <http://vivreagatineau.ca/collectes-speciales-a-lhorizon/>. I encourage you to download the DTRITUS application to be informed and review alerts for the various collection services offered.

### Cycling path

The bicycle path project on Lucerne Boulevard is identified in the priority projects of the Master Plan for the bicycle network. It should be noted that the planning of the work will nevertheless have to take into consideration the results of the study currently underway on the routes for the public transit project structuring to the west.



### Potentially dangerous dogs

A project concerning dogs qualified as potentially dangerous will soon be presented to the municipal council.



## Noise régulations

Ville de Gatineau has adopted a By-law to reduce the noise caused by various actions such as sound devices (perceptibility outside the building) that disturb the peace of the neighbourhood, the use of a vehicle equipped with a sound device whose noise is perceptible by the neighbourhood, public advertising, loading or unloading operations between 10 p.m. and 7 a.m. that affect public peace. These Regulations also apply to work on construction sites except in the case of emergency work. Dent removal work of any kind or the use of noisy instruments (power saw, lawnmower, snow blower or others) is prohibited at night if it disrupts public peace. The use of engine brakes is prohibited on City territory.

All in all, after 11 p.m., it is a question of adopting a good neighbourly attitude so in order to maintain peace and tranquillity in the neighbourhood.

An officer in charge may order any person to immediately stop these noises, institute criminal proceedings against any person who contravenes any provision of the by-law.

## Educational radars

Fifty new educational radars have been installed on the streets of Gatineau, in addition to the twenty others already in existence. For District 5, four new educational radars will be installed on Saint-Raymond Boulevard, Lucerne Boulevard, Dominique Street and Bégin Street respectively. In addition, speed reduction measures, including speed bumps, ensure better safety for both residents and motorists. Let's face it, speed has no place in Gatineau, it's better to slow down and respect the highway code.
